# A Very Special Piece of Land

Morva William's bequest to the Bolton Street Memorial Cemetery is a very special gift from a Wellington identity who died last year aged 95.

Morva lived next to the Easdale Street entrance of the historic settlers' cemetery for more than 60 years, and gifted almost half of her property to the Wellington City Council before she died as she wanted to preserve the unique environment of trees and birds which she had created.


Morva a former teacher and librarian, was a great walker, and never owned or drove a car. She was a pioneer of organic gardening methods and the garden is a fascinating example of her interpretation of a subtropical eco system in the Wellington environment. The trees and plants including mature magnolias, nikau palms, taros and a papaya are a testimony to her composting and organic gardening interests. Morva derived great pleasure from her garden and the birds which she fed there every day. Woodpigeons were her favorite callers. To feed the soil she collected seaweed from Lyall Bay and to keep her magnificent Magnolia campbelli healthy she inserted a copper rod into the trunk in order to

ward off x-rays from the local medical centre which she believed would kill the tree.

The plants will be appreciated by the garden staff from Wellington City Council, who will be in charge of developing and opening the area to the public in the near future.

This innovative and generous gift to the people of Wellington may be an example of how the park can be developed in future.



# Forster Goring (1810-1893) – Clerk to the Executive Council

Forster Goring, the fourth son of Sir Charles Goring, 7th Baronet, was born in London on 9 April 1810. On 30 November 1829 his father Sir Charles Goring made, application for his son to enter the army by way of purchase of a commission, but it was not until 12 July 1832 that he joined the 1st Dragoon Guards at the age of 22 years. The price of the commission was £800 and this amount was lodged with bankers Greenland & Co. His rank was Cornet. For



some unknown reason Goring sold his commission and retired from the army on 23 January 1834. It is not known what his occupation was meantime but in May 1839 he was listed as a Cornet in the Royal Sussex Militia - his brother Harry Dent Goring being a Captain.

On 19 July 1839 he married the Hon Sydney Eloise, daughter of the 3<sup>rd</sup> Viscount Avonmore and on 20 August 1860 he arrived in Auckland from London with his wife and six children, on the ship Persia of 1684 tons, Captained by J. H. Smith.

In 1862 he was appointed Clerk of the Executive

Council of the colony, in place of James Holt who had resigned. His salary was £150 per annum. In the civil list of 1871 his annual salary was increased to £250 and in 1874 further increased to £300. He retired on 30 May 1889 on superannuation of £150 per annum.

His wife Sydney Eloise Goring died at "The Cottage, Kaiwarra" on 13 March 1883 of paralysis.

Forster Goring holds the record for being the longest serving Clerk - nearly 27 As Clerk, Goring years. counter-signed the Order in Council dated 10 March 1869 instituting the New Zealand Cross. The Order was in breach of the Sovereign's prerogative as the "Fount of all Honour" and resulted in the Secretary of State for the Colonies informing the Governor Sir George Bowen that he had exceeded his authority!

Goring's name is perpetuated in a Thorndon street. In "The Streets of my City" F. L. Irvine Smith records that Goring Street,



off George Street, cut through the property of Walter Johnston and was named after his father-in-law Forster Goring.

At the date of his death three of Forster Goring's family lived in New Zealand – Forster Yelverton Goring, later Colonel , Mrs W.W. Johnston who lived with her husband at Highden near Feilding and Barry Y. Goring. The other three children lived in England.

Forster Goring died in Hawkstone Street on 10 December 1893 and is buried with his wife in the Bolton Street Cemetery.

#### Presentations

Nick Perrin has given presentations on behalf of the Friends, to the Kilbirnie Branch of the NZ Society of Genealogists on 3<sup>rd</sup> September, and Wellington Branch of the Historic Places Trust AGM on 30 September. These provided an

insight into the researching of the Bolton Street Burial List together with Park history and biographical information.

#### Park tours

Park tours this year have been variously guided by Nick Perrin, John Daniels and David Dunsheath. Two tour tours were provided as part of the Spring Festival that netted substantial donations. Of these, the mid-week evening tour on 24<sup>th</sup> September proved overwhelmingly popular (estimated attendance of over 70) in spite of the blustery, moon-less conditions. It has prompted us to investigate the purchase of a portable sound system.

As a follow-up to Nick Perrin's presentation to the Kilbirnie Branch of the NZ Society of Genealogists, they were given a guided tour on 5<sup>th</sup> November.

#### Park developments

Recent visitors to the Park will have noticed within the Jewish Cemetery area, the trial of a commercial cleaning process for headstones. John Daniels is coordinating the Friends, in partnership with the Council, to assess the success and inherent risks of this process, before more cleaning is done. We are working towards the future adoption of a suitable heritage conservation plan/guide that will strengthen the current intuitive approach to repairs and maintenance of heritage fabric.

Visitors might also have seen the Council's improvements to gravel paths adjacent to the upper end of the Dennis McGrath pedestrian bridge.

#### City Council liaison issues

- 1) The need for a fool-proof process for on-going administration of the Burial List, and associated updating of the paper printout in the Chapel, is still being sought after a further meeting in September. Meantime, the electronic version of the Burial List has been recently updated with all the amendments submitted by Nick Perrin to the Karori Sexton.
- 2) The Friends have drafted various material for the Council's proposed upgrading of its web pages, including descriptive and historical information for promotion of the Park. We have also sought to have a separate Friends webpage within the Council website where we can provide information and promotion material about our Society.

#### 3. Matters arising from the previous minutes

There were no substantive matters arising from the minutes of the previous AGM. The ideas raised for action at the 2002 AGM and the 2003 AGM will be further referred to by the committee through the coming year.

#### 4. Chairperson's report

The Friends have made quiet progress in the last year, which I hope will underpin tangible achievements in the forthcoming year. The Committee has met twice during the year to consider administrative and cemetery matters, and has published two newsletters (November 02 and March 03). At the time of writing we estimate a subscribing membership of 77, the majority of whom are fully financial up to 31 March 2004. We extend once again, our appreciation to members for their continued loyalty during the second part of our subscriptions catch up in March this year, which will return us to normality in April 2004.

We continue to maintain a dialogue with Wellington City Council on management of the burial list, Park promotion and other issues. The Council has progressed with grave restorations with enthusiasm, in addition to their enormously important general maintenance and planting work that is appreciated by all Park users.

During the year we established first contact with the Dunedin based Historic Cemeteries Conservation Trust of New Zealand. This may develop into a relationship that will help the Friends in conjunction with the WCC, to develop a conservation policy and guideline for the extent and nature of future restoration work to be undertaken on graves, memorials and other heritage items within the Park.

As previously reported, gifting of neighbouring land to the Park by the late Morva Williams is about to be finalised after two and a half years.

Our committee was strengthened at the last AGM with the addition of Judy and Karl Bale. My thanks also go to committee members Anne Brosnahan, Rachel Brown, Helen Carey, John Daniels, Warwick Greenwood and Nick Perrin for their various valued contributions during the year.

Moved Warwick Greenwood and seconded by Bill Alington that the Chairperson's Report be accepted. There being no further discussion the motion was put.

### 5. Treasurer's Report and Financial Statements

The Treasurer, Warwick Greenwood, spoke to his Financial Report and Statements (see below). Various matters were raised:

- The Society has sufficient funds to meet its current requirements.
- The Society is now paying for the accounts to be audited. In reply to a
  question, Warwick noted that it is good practice for this organisation to
  audit its accounts for the purpose of its credibility.
- One other comment was that instead of Profit/Loss it maybe more appropriate to use the terms Surplus/Loss.
- Warwick noted that it maybe appropriate to increase subscriptions in the future, as there has been an increase in costs over the year.

Moved Warwick Greenwood, seconded by John Daniels that the Treasurer's report be accepted.

#### 6. Report by the Wellington City Council

Mike Oates presented an oral report on the activities of the Wellington City Council in the Bolton Street Memorial Park. His comments included:

- Tony Williams and Amber Wilkie both resigned about two months ago. Replacements are currently being sought.
- Grave restoration continues with the contracted help of Mr Bob Lamb. There is a need for future prioritisation. There is a management plan and conservation plan being prepared for the Karori Cemetery. It is appropriate that the same protocols operate in the two cemeteries.
- Possibility of developing some special tours, eg those whose lives was lost on the *Penguin*.
- Shortly there will be a press release on the gifting of the land at 2 Easdale Street. There are plans afoot for landscaping including a seat.
- Horticulturally, 45 new roses have been planted. Cleaning up behind the cottage continues. The conservation plan on the sexton's cottage needs to be revisited to ensure it is fully implemented.
- Management arrangements for the burial list database are still being worked on.
- Improving signage in the Memorial Park is still a priority.
- The redevelopment of the Begonia House will be opened in eight weeks.
- Mike emphasised the need for the Friends of Bolton Street Memorial Park to comment on the Karori Cemetery Management plan when it is released.
- In the financial year 2004/05 the linkage between the Rose Garden and the Memorial Park will be improved.

#### 7. Change of Rules

It was moved by David Dunsheath and seconded by Warwick Greenwood that the changes to the society's rules, as set out as Motion 1 on page 5 in newsletter no 55 June 2003, be treated as a block and that the changed rules be accepted.

The meeting was followed by a presentation by Ron and Lorraine Clare, convenors of the Heritage Rose Society, and Helen Carey.

Originally roses were planted around the graves to prevent wandering stock from damaging the surrounds but many roses have since been added to the area and thanks to the work of Ron and Lorraine and the Wellington City Council Garden Staff, led by Helen Carey, the collection has been declared a World Heritage Rose site.

A list of the roses in the Park and a site map of their positions is available from the Tree House in the Botanic Gardens.

The best time to view this outstanding collection is during November when most of the roses are in full bloom.
