4 Chairperson's Report

Annual Report 1999-2000

Our updated listing in the Wellington City Council publication 'Branch Out' prompted a quick review of what The Friends' are currently about. I share our findings with you.

- Preserve, protect and develop the wooded and historic atmosphere of the three cemeteries (that formerly occupied the Memorial Park area).
- Support Wellington City Council in maintaining the graves, and in developing and promoting the Park.

Encourage families and groups to repair damaged graves, to sponsor grave repairs and to support the Society.

These aims have evolved since our original formation, in 1977, in reaction to the motorway construction that devastated large areas of the cemeteries. I would like to thank our dedicated committee for their substantial achievements this last year towards fulfilling these aims, as I will now summarise.

Significant progress has been made towards integrating the Friends' stand-alone burial list thin the Council's Cemeteries Records System, for greater physical security and wider access to its content. (This follows thousands of volunteer hours spanning more than a decade by members under Nick Perrin's untiring stewardship, to compile and verify the list.). We are sure the list will continue to evolve, albeit much more slowly, as further information comes to light. We are still drafting an associated management plan/protocol encompassing a partnership between the Council and the Friends, to safeguard the integrity of the burial list data that now provides a definitive advance over the source records (some of which are proven to be inaccurate and conflicting).

The initial stage of park interpretation was the new Chapel display completed last year. This has been followed by our liaison with the Council (and Isobel Gabites of Boffa Miskell) to develop several interpretation panels for placement within the Park. Our role has been to review draft texts for accuracy and balance of both factual and 'human interest' details, seek additional appraisals as appropriate, and offer recommended changes. These panels are a prelude to next year's third stage of interpretation, comprising a self-guide Heritage Trail throughout the Park.

The Friends conducted three guided historical-interest tours of the Park at the request of various groups. We have spread the Friends' tour guiding capabilities among several core tee members, and so thanks are due to Nick Perrin, John Daniels, Annette Fairweather and Diane Comber for their contributions to this role.

A new project for the publication of biographical material was tentatively explored. Dialogue with the Dominion Newspaper was established regarding our proposed regular contributions to a column (perhaps monthly) on selected Wellington entities within the Burial List. This is considered a useful form of publicity for the Park and its historical significance, particularly if we can include relevant illustrations. We envisage assembling readily-available information on selected personalities, from our previous newsletter articles and other sources as appropriate. We will strive for a balance of factual and 'human interest' material. To this end we are keen to involve volunteers who would like to actively help with various aspects of this project, i.e. compiling written and photographic material, preparing the texts, reviewing drafts and project managing all these activities to ensure we can meet relevant deadlines.

This year has seen the creation of a listing of preservation & restoration projects within the Park from our liaison with the Council. It currently comprises about 70 individual entries relating to individual graves, access paths and vegetation issues. We envisage it to be a resource to be shared between the Council and the Friends for communication of project priorities and overall smarter decision making. It is intended that we periodically update the list as some projects are completed, others' priorities are adjusted, and yet other projects are identified for the first time.

We have recognised, through Margaret Alington and others, the importance of retaining the unique heritage environment attributable to not only the grave stones and meritals but also their fenced surrounds that we must endeavour to repair and replice as traditionally as practicable. To this end we will need to develop guidelines on aspects of this work, as well as research how we might:

- retain/enhance the legibility of headstone/headboard/monument inscriptions affected by moss and decay without inadvertent damage to the stone or wood
- restore/repair metal and wooden railings as faithfully as possible to their
- relocate selected treasured items for better protection from decay and/or vandalism, in a safer environment,

all in an economic, reliable and safe manner. This is a challenge for us next year.

Three newsletters were prepared during the year as our sole means of communicating our direction and progress to our members and akin organisations. Our declining membership (approximately 60) is of on-going concern. We are seeking new members interested in contributing to the Society's aims, plus additional families of those within the Park. Closer relations with akin organisations is also a goal. At the invitation of the Friends of Botanical Gardens, several committee and other members attended a very pleasant cocktail evening in the Begonia House in February.

I would like to conclude with a further thank you to all members of the committee for their support through participation in the diverse range of activities we have progressed. Our particular thanks goes to Annette Fairweather who wishes to step down from the committee after several years' of valuable contributions.

6 Report by Wellington City Council

Over the past nine months since the last AGM development has slowed follows: the refurbishment of the chapel and construction of the viewing deck. Implementation of the Interpretation and Wayfinding Strategy continues. Major projects include:

- Redevelopment of the Seddon Entrance with plans finalised and work due to begin
 in early July
- Development of the Historic Trail with associated signage on significant sites. This
 project has started with signage due for completion by the end of June.

Headstone Restoration

No grave restorations took place this year. Funding has been set aside for work to continue from July 2000.

Plant collections

Plantings around the chapel have been renovated and a new *Camellia sasanqua* hedge planted on the eastern side and a *Buxus* hedge on the southern side.

Irrigation has been installed in the Seddon Garden and the system repaired around the chapel.

General maintenance

Several flights of steps have been installed to improve access to certain areas. These include behind the Sexton's cottage and in the rose species area below Sydney Street Path.

Areas below the new deck and under the acacias on the motorway edge have been planted with natives.

There has been some vandalism of the new path signs. These have been replaced and strengthened with a wider base.

The map board at the Easdale Street Entrance was damaged and was removed for repairs.

In the Public Cemetery Register, it was recorded under entry 858 that one Peter M. Anderson, aged 48 was buried by the Reverend Ogg (Presbyterian) on 11th November 1877. No plot was recorded, and the only other information was that the undertaker was

Mr Shotter, the City Sexton, took a photograph of the grave at plot 39.B that he called "Grave of Anderson (first name unknown)". The wooden cross on this grave had traces of a painted inscription, and after the grave was removed for the motorway, the cross was taken to DSIR Forensic Division at Gracefield to see if they could decipher it. From the transcript in the National Library, this is what they found-

HIRUNDER HVILE SLOVEL AF PETER MIEART ANDERSEN FODL I KJARTMINDE I DANMARK DEN 28^{DE} SEPTEMBER 1829 DOD I WELLINGTON DEN 8^{DE} NOVEMBER 1877 ELI TUBI KUN GAVEL FORUD

Since the inscription was obviously Danish, I got a Danish colleague at work to translate it, and correct any deciphering errors, if possible. She suggested the following, but could


The translation (thanks to Pi Willumsen):


Below rests the soul of Peter Mieart Andersen Born in Kjerteminde in Denmark on 28th September 1829 Died in Wellington on 8th November 1871 [Eli tubi= ?? (Latin?)] (kun=only/alone)[gavel=??](forud=forward)

"Kjerteminde' (Kerteminde) is a small coastal town on the island of Fyn (the large island between Zealand and the Jutland peninsula). It is likely that Peter was a sailor on a passing ship, and that his inscription was painted by his crew mates. Perhaps they were Norwegian, which might explain the mis-spelling of Kerteminde?

If anyone is prepared to hazard a guess as to what the last line might mean, bearing in mind that the deciphering might be very faulty, and that it could be Latin or Danish, then I would be interested. Perhaps it includes the name of his ship.

I can see no trace of the inscription on the reinstated wooden cross at grid P10 10 (see photo), but more biographical work is planned.
